

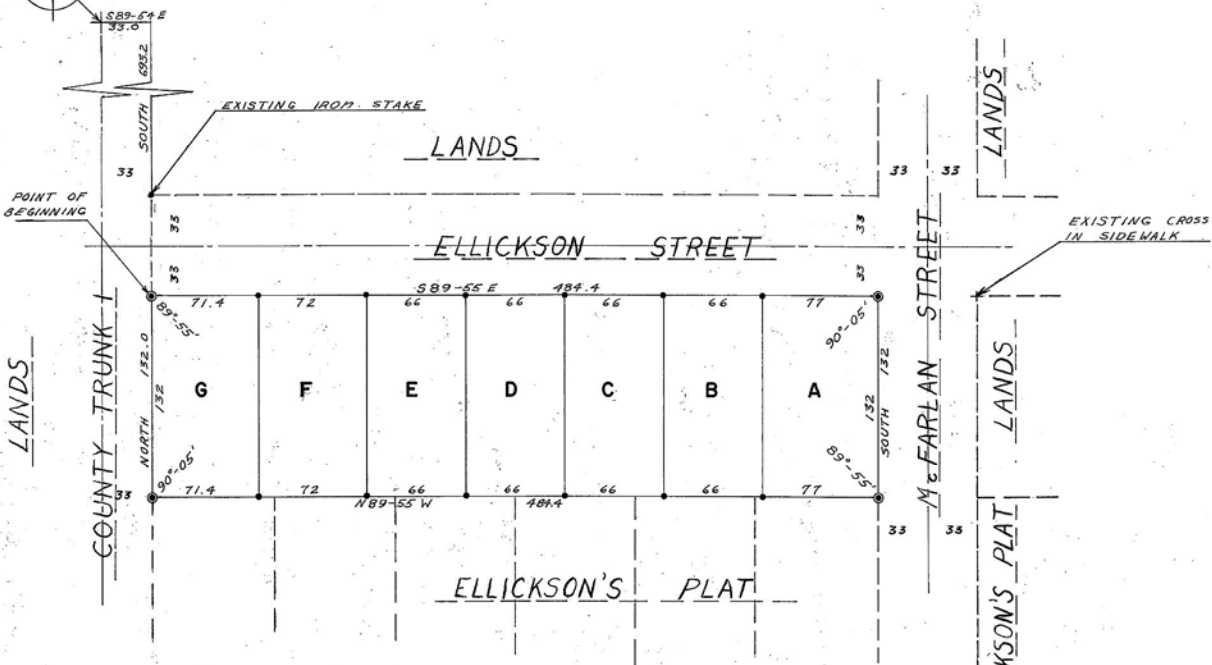
ASSESSOR'S PLAT NO. 1

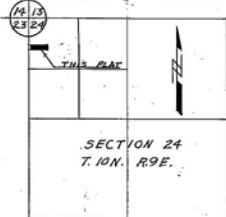
