

**ORDINANCE NO. 2015-01**

**VILLAGE OF ARLINGTON  
COLUMBIA COUNTY, WISCONSIN**

**AN ORDINANCE ELIMINATING THE SEWER CREDIT GIVEN FOR THE  
USE OF OUTSIDE DEDUCT (IRRIGATION) METERS**

The Village Board of the Village of Arlington, Columbia County, Wisconsin, discussed and took action on August 11, 2014 and has subsequently determined an Ordinance was required to enact this provision:

Whereas, the Village of Arlington, Wisconsin, owns and operates Arlington Wastewater Treatment Facility; and

Whereas, has determined the use of outside deduct meters to be wasteful.


Now, therefore, be it ordained by the Village of Arlington Board, that;

- 1) All future irrigation meters be plumbed into the home effective January 1, 2015;
- 2) All installed irrigation meters will receive a quarterly fee of \$21.00
- 3) All external deduct or irrigation meters will no longer be read as of January 1, 2016


This ordinance shall take effect upon passage and publication as provided by law.

The provisions of this ordinance are severable. If any provision of this ordinance is invalid or if the application of any provision to any person or circumstance is invalid, such invalidity shall not affect the provisions or the applications of such or the remaining provisions which can be given effect without the invalid provisions or invalid application.
