**A RESOLUTION AMENDING THE VILLAGE OF ARLINGTON FEE SCHEDULE  
PURSUANT TO VARIOUS PROVISIONS OF THE VILLAGE CODE OF ORDINANCES.**

**RECITALS:**

**WHEREAS**, on December 14, 2020, the Village of Arlington Board of Trustees amended the Village Fee Schedule; and

**WHEREAS**, several sections of the Code provide for fees for various licenses, permits and applications to be established by resolution of the Village Board from time to time; and

**WHEREAS**, the Village Board desires to amend the fee schedule to establish current fees for permits, applications and other matters as allowed for by the Code.

**NOW, THEREFORE, BE IT RESOLVED** that the Village Board does hereby adopt the following fee schedule to be and remain in full force and effect unless and until modified by further resolution of the Village Board.




